It operates through the following segments: Google Services, Google Cloud, and Other Bets. The Google Cloud segment refers to infrastructure and platform services, collaboration tools, and other services for enterprise customers. The Other Bets segment relates to the sale of healthcare-related services and internet services. The company was founded by Lawrence E. Page and Sergey Mikhailovich Brin on October 2, 2015 and is headquartered in Mountain View, CA.
