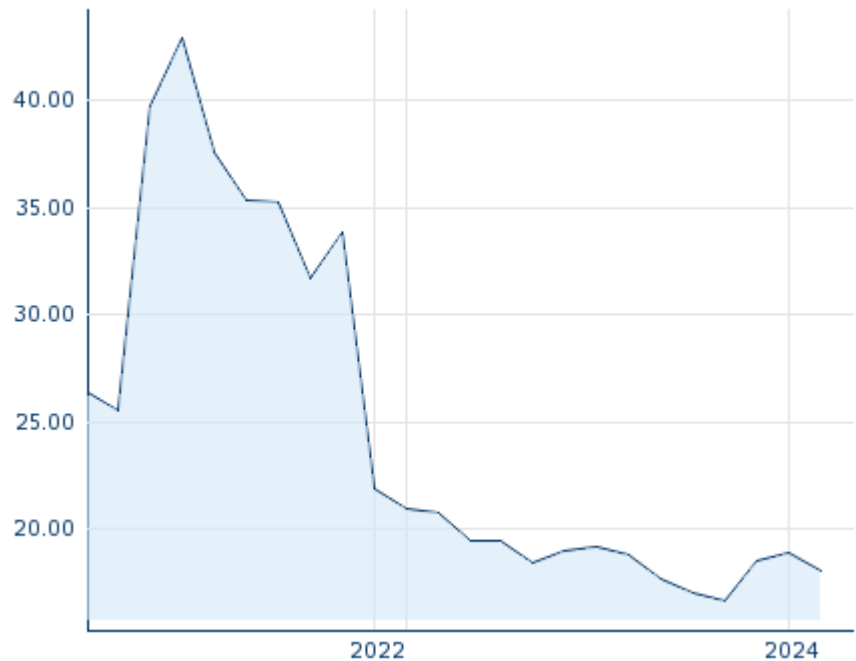

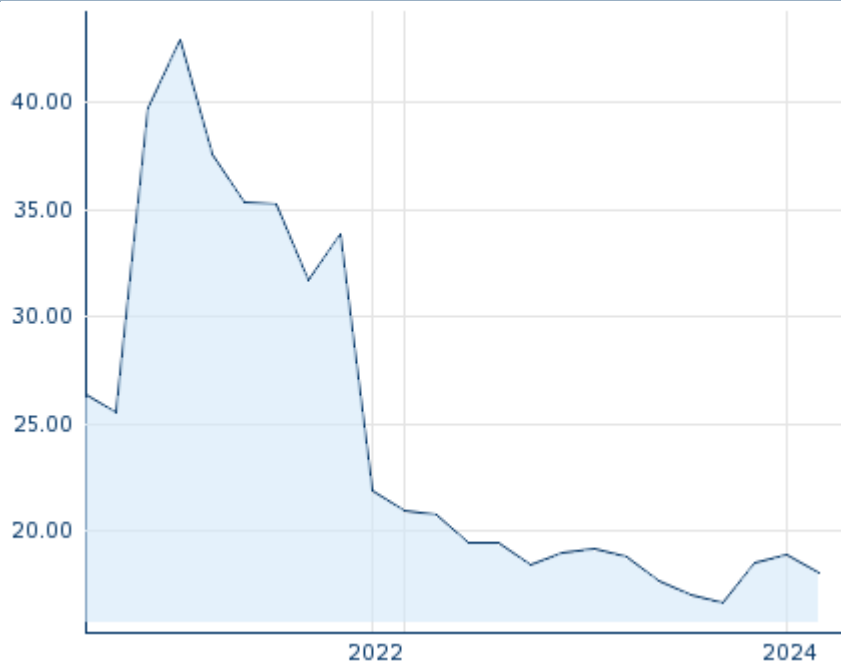

The Building and Technical Trade segment focuses on the chains concepts, marketing, purchasing, logistics services, and store site network.
