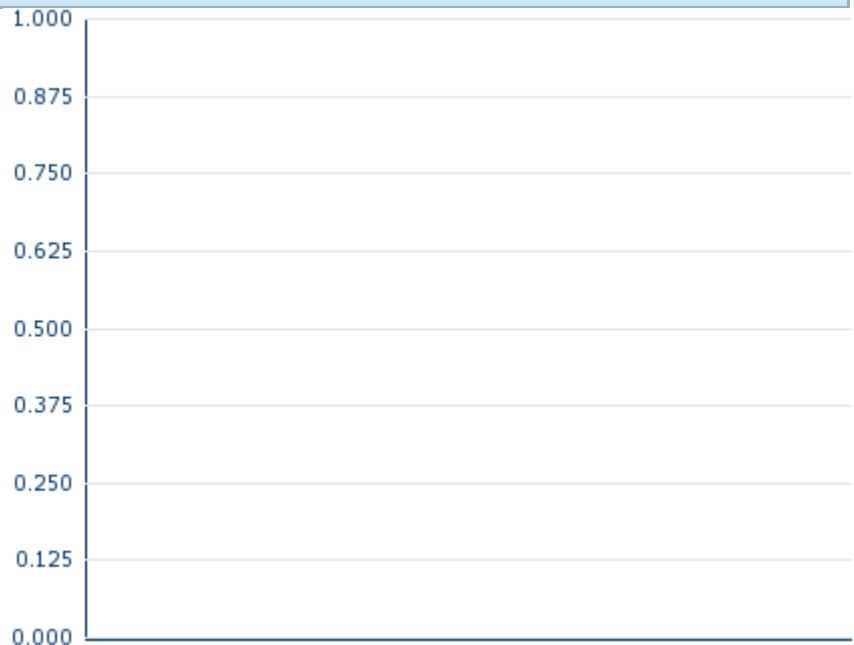

The Farmers segment focuses on non-claims administrative and management services to the Farmers Exchanges, which are owned by policyholders.
