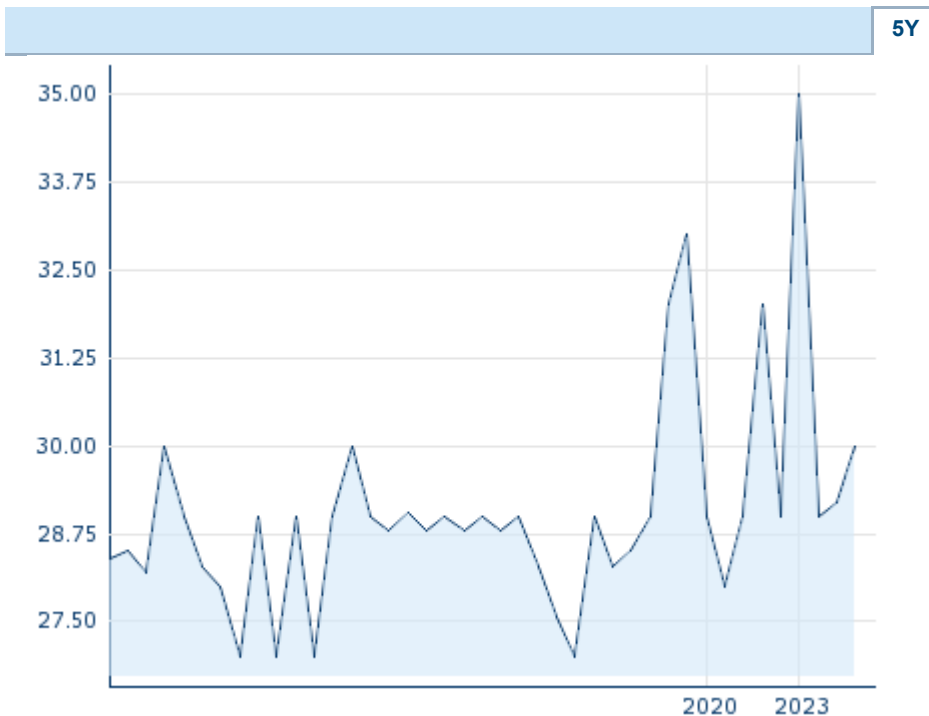

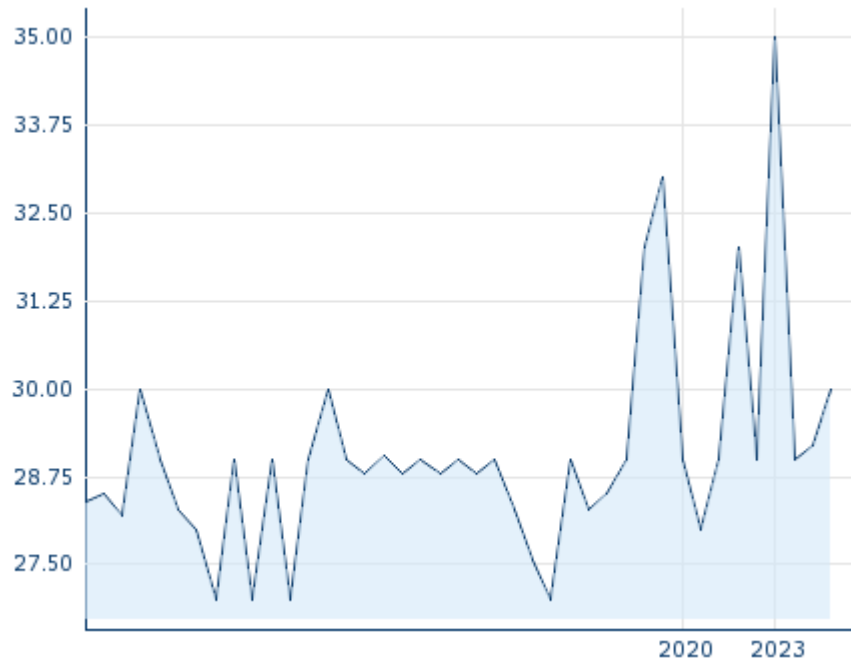

The Client segment refers to the computing platforms, which are a collection of technologies that are designed to work together to provide a more complete computing solution.
