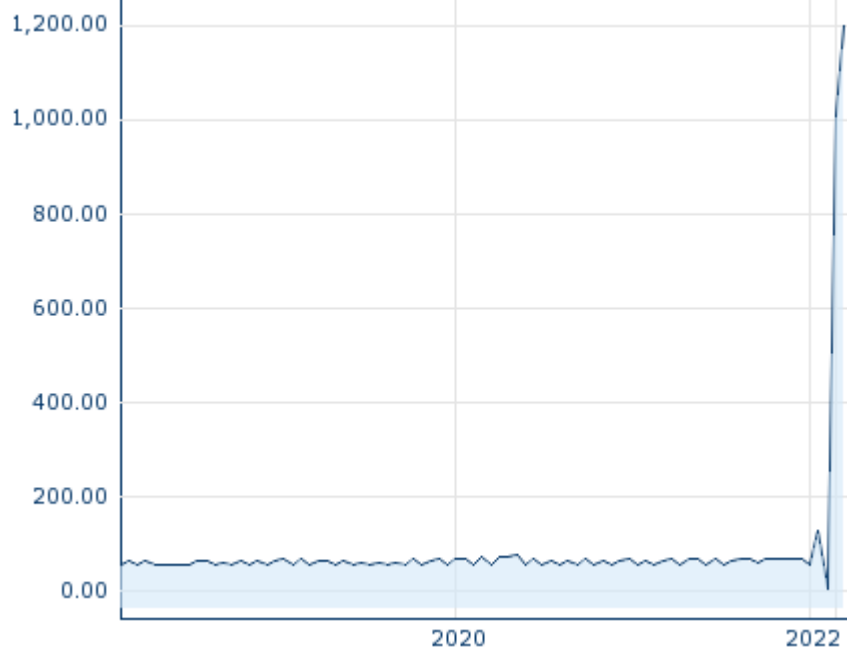

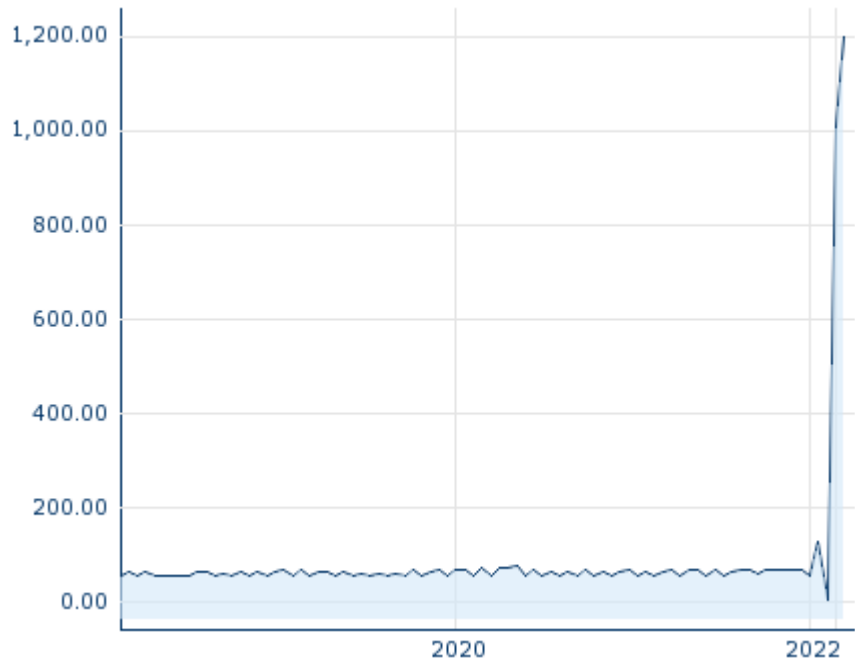

It operates through the following segments: Google Services, Google Cloud, and Other Bets.
