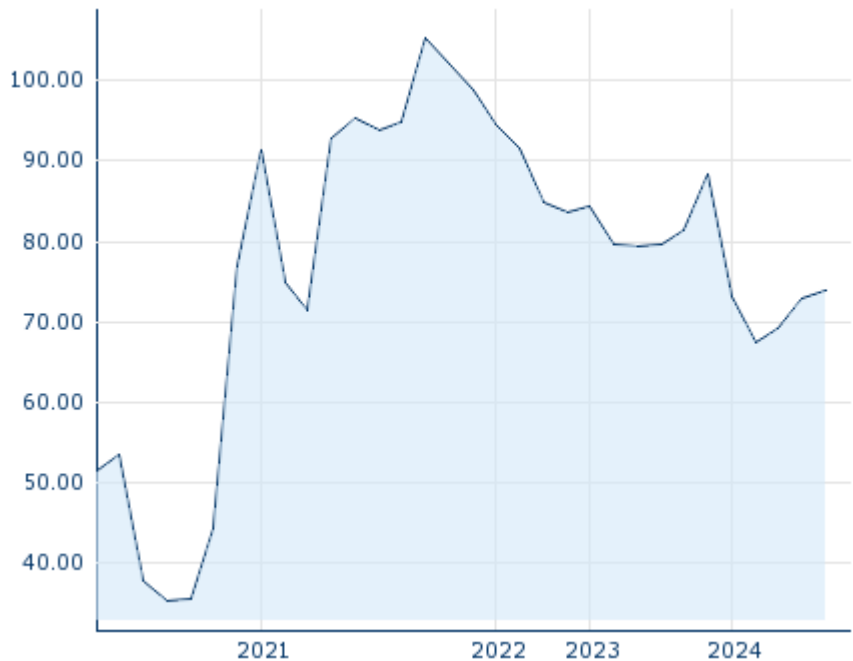

The New Renewables segment focuses on wind and photovoltaic generation technologies. The Sales segment is involved in trading and sales activities.
