The Mercedes-Benz Cars & Vans segment develops, manufactures and sells cars comprising premium and luxury vehicles of the Mercedes-Benz brand including the brands Mercedes-AMG, Mercedes-Maybach and Mercedes-EQ as well as small cars under the smart brand. The Mercedes-Benz Mobility segment supports the sales of the Group's vehicle segments worldwide and also provides services such as fleet management in Europe, which primarily takes place through the Athlon brand. The company was founded by Gottlieb Daimler and Carl Benz in 1926 and is headquartered in Stuttgart, Germany.
