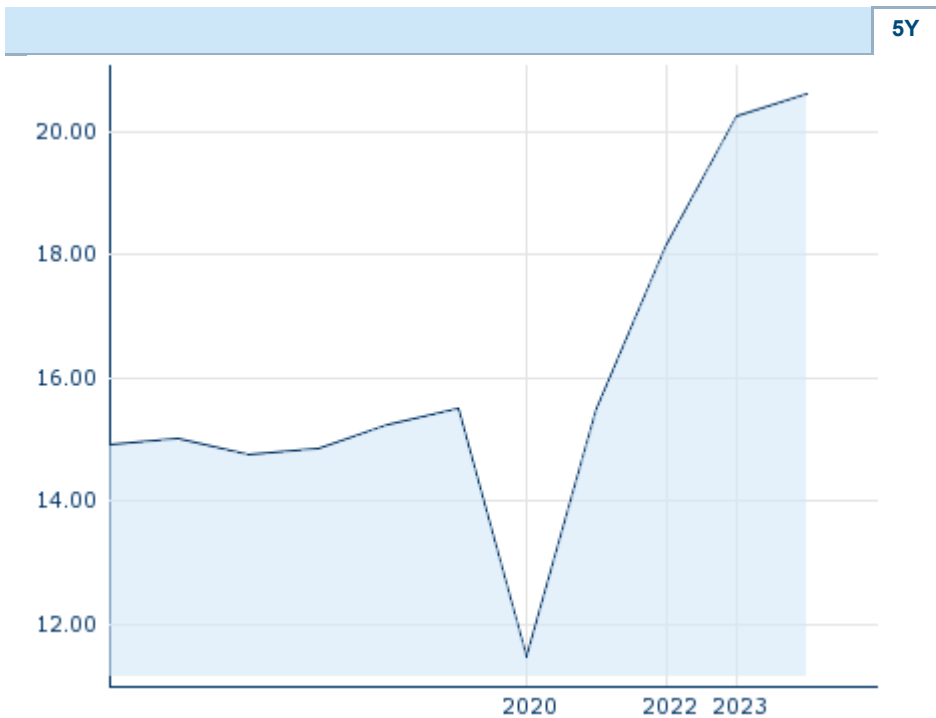

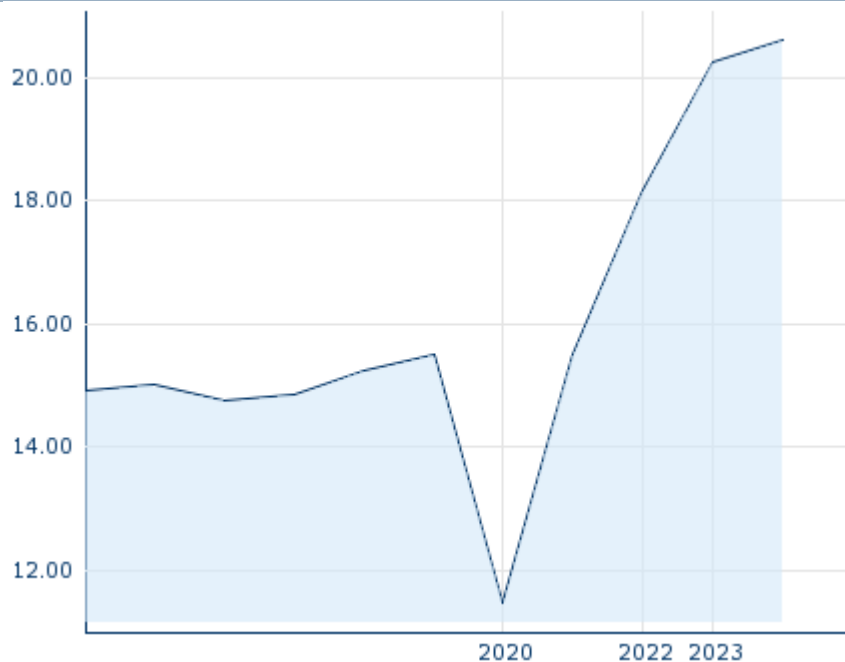

The United States segment combines mobile activities in the U.S. market.
