



The segment AT/CH covers PORRšs entire responsibility for the home markets of Austria and East Switzerland. The segment DE comprises the majority of PORRšs activities in Germany. The segment PL holds complete responsibility for Poland that focuses on office, industrial and hotel construction as well as on buildings and facilities for the public sector. The segment CEE is focused on the home markets of the Czech Republic, Slovakia and Romania. The segment Infrastructure International PORR focuses on contracts in infrastructure construction and on cooperation with local partners.
