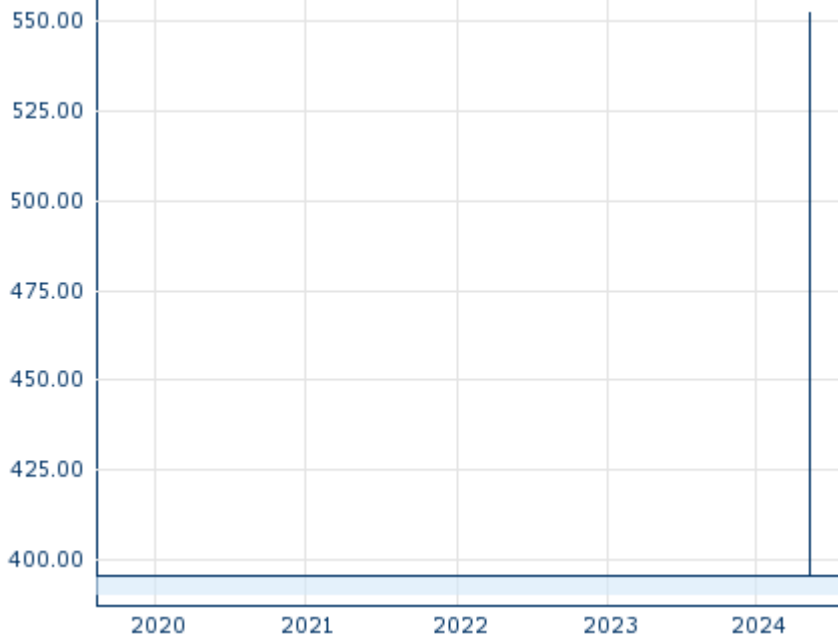

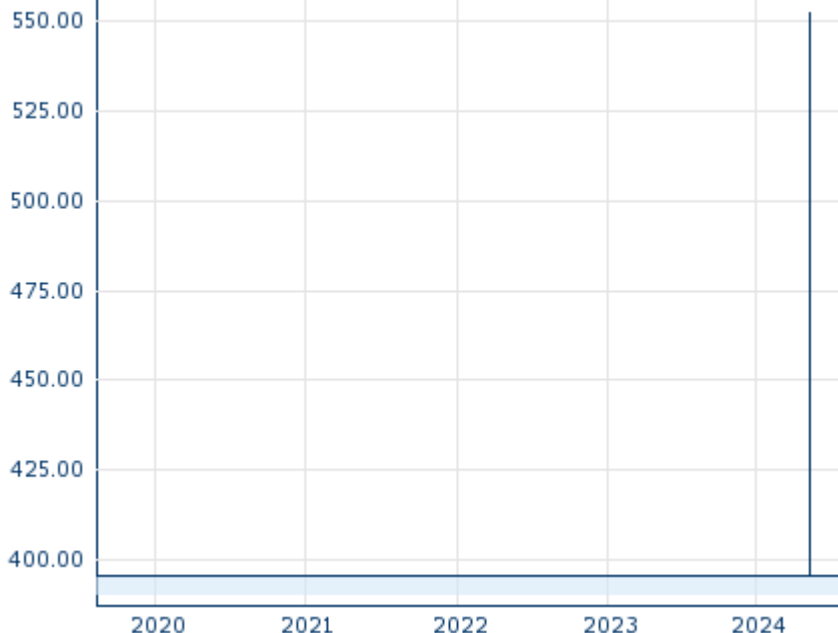

The ALM and Centre segment includes central operations such as financing of other group's segments, including liquidity, interest rate risk, and FX risk management.
