It operates through the following business segments: Passive Components, Sensor Application Products, Magnetic Application Products, Energy Application Products and Others. The Passive Components segment offers ceramic capacitors, aluminum electrolytic capacitors, film capacitors, inductive devices, high-frequency components, piezoelectric material components, circuit protection devices, and sensors.
