The Energy segment is comprised of brazed and fusion bonded heat exchangers, energy separation, gasketed plate heat exchangers and welded heat exchangers. The Food & Water segment is consist of decanters, food heat transfer, food systems, hygienic fluid handling and high speed separators. The Marine segment represents boiler and gas systems, marine separation and heat transfer equipment, and pumping systems. The Operation & Other segment covers the procurement, production and logistics as well as corporate overhead and non-core businesses.
