



It operates through the following segments: Europe, Middle East, and Africa (EMEA); North America; Operations; and Asia-Pacific (APAC). The EMEA segment includes mature markets showing more modest growth and a larger market share where the strategy is to improve profitability through operating leverage and also other emerging markets with higher growth expectations. The North America segment focuses on increasing market share in the largest global pool market, taking advantage of growth in the smart pool market, customer loyalty, and a wider range of products.
