The Savings segment deals with products that include long-term saving for retirement with no long-term interest rate guarantees. The Insurance segment is responsible for the group's risk products. The Guaranteed Pension consists of products encompassing long-term savings for pensions, where the customers have a guaranteed return or benefit on the saved funds.
