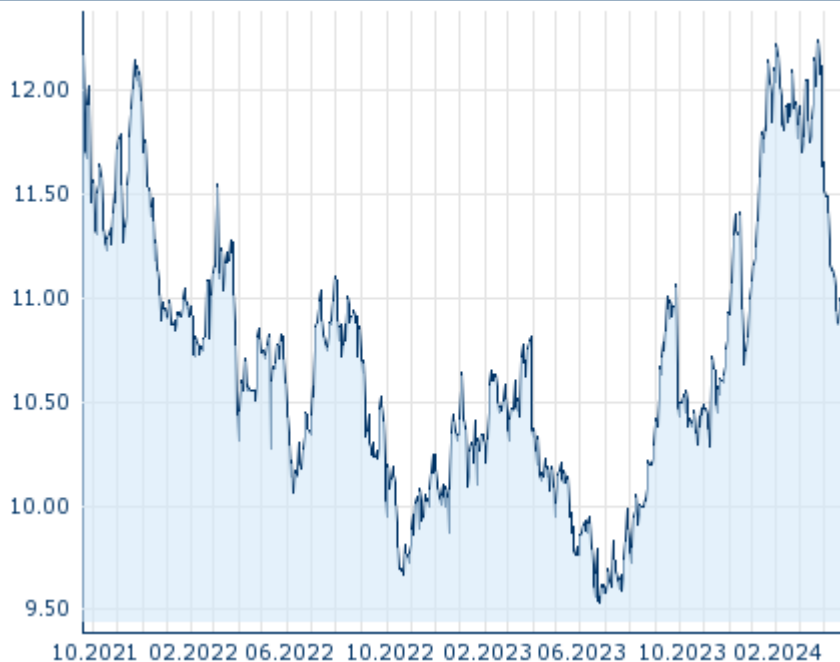

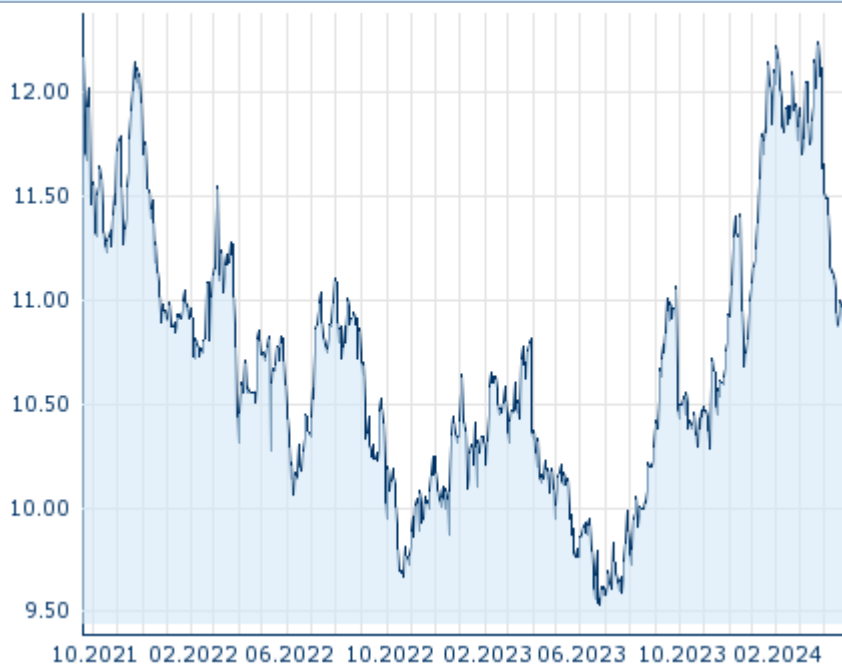

It operates through the following segments: Consumer, Corporate, Distribution, Yahoo and LINE, and Others.
