It operates through the following segments: Conventional Power Generation, Heat Generation, Renewable Power Generation, Trade, Distribution and Other Operations. The Conventional Generation segment explores and generates energy from conventional power plants. The Renewables segment engages in the generation of electricity from in pumped-storage power plants. The Supply segment includes sale and purchase of electricity and gas in the wholesale market. The Distribution segment engages in the distribution of electricity and management of local distribution grids.
