The Sempermed segment produces and sells examination, protective, and surgical gloves. The Semperflex segment develops and markets hoses reinforced with fabric or wiring. The Sempertrans segment manufactures and distributes transport and conveyor belts. The Semperform segment focuses on the production and sale of moulded extruded products. The Sempersal segment refers to the development, production and sale of sealing profiles for the construction industry and other industrial applications. The company was founded by Johann Nepomuk Reithoffer in 1824 and is headquartered in Vienna, Austria.
