The Savings segment deals with products that include long-term saving for retirement with no long-term interest rate guarantees. The Insurance segment is responsible for the group's risk products. The Guaranteed Pension consists of products encompassing long-term savings for pensions, where the customers have a guaranteed return or benefit on the saved funds. The Other segment comprises Storebrand ASA and the company portfolios and smaller subsidiaries. The company was founded on May 4, 1847, and is headquartered in Lysaker, Norway.
