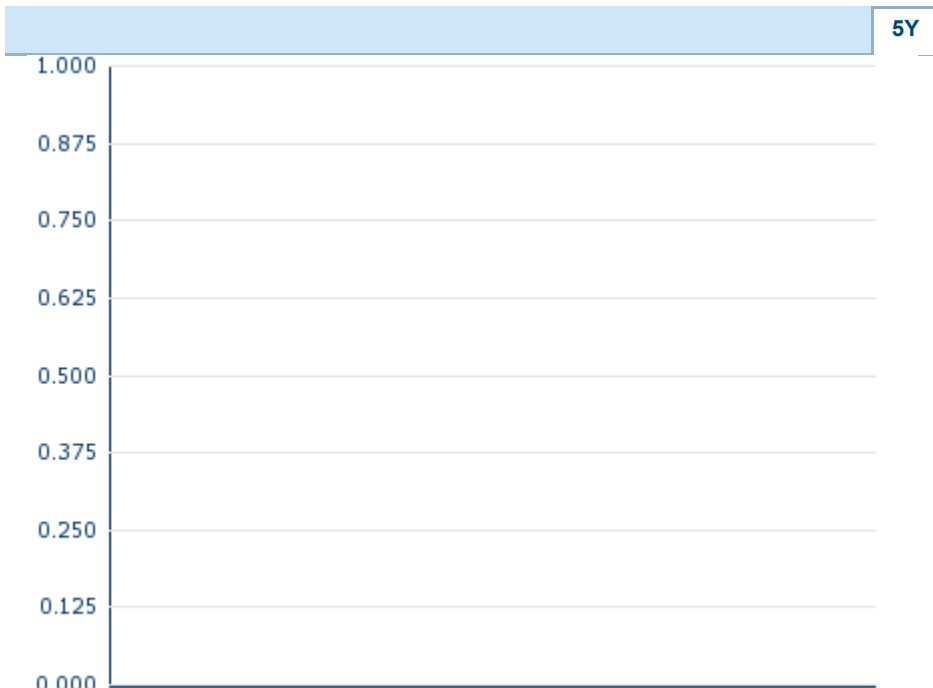

The company was founded in 1811 and is headquartered in Vienna, Austria.
