AUGA group AB engages in the manufacture and sale of organic food products. It specializes in crops, dairy cows, chicken and mushroom growing. The firm operates through the following segments: Crop Growing, Dairy, Mushroom Growing and Fast-moving Consumer Goods. The segment Crop Growing grows organic wheat, legumes, rapeseed, sugar beets, and other crops, including organic vegetables and organic feed for livestock. The Dairy segment includes organic milk production and cattle rising. The Mushroom Growing segment grows white and brown champignons, portobello, eringi, shiitake mushrooms and produces composed used for mushroom growing. The Fast-moving Consumer Goods segment offers end-consumer products (FMCG) including ready-to-eat soups, preserved mushrooms, packaged fresh and preserved vegetables, bottled milk, oat flakes, and other products.
