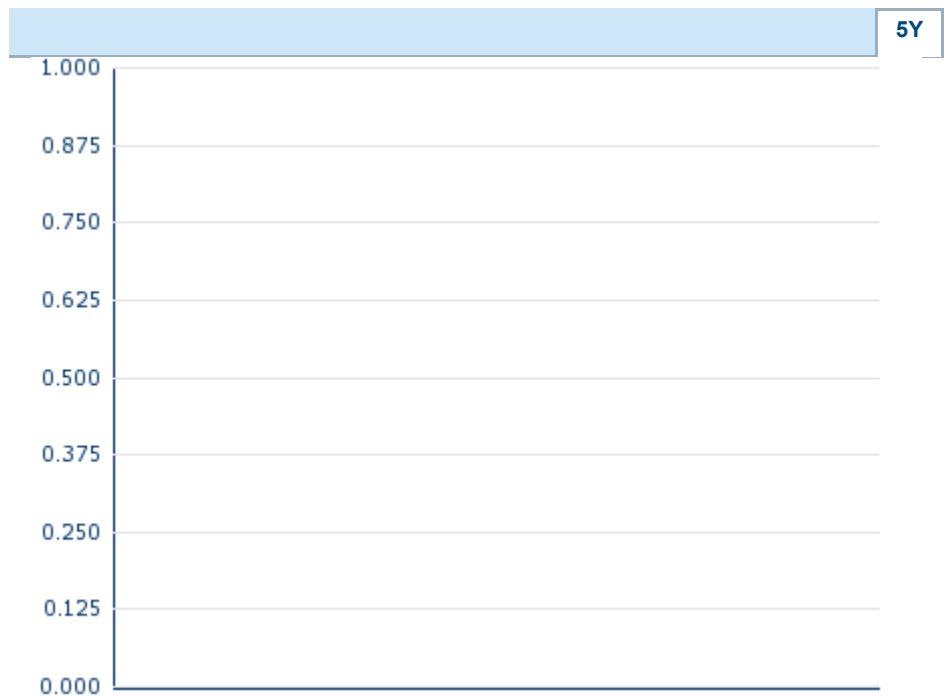

The Retail Banking segment generates income from the sale of products and services to personal customers and small companies.
