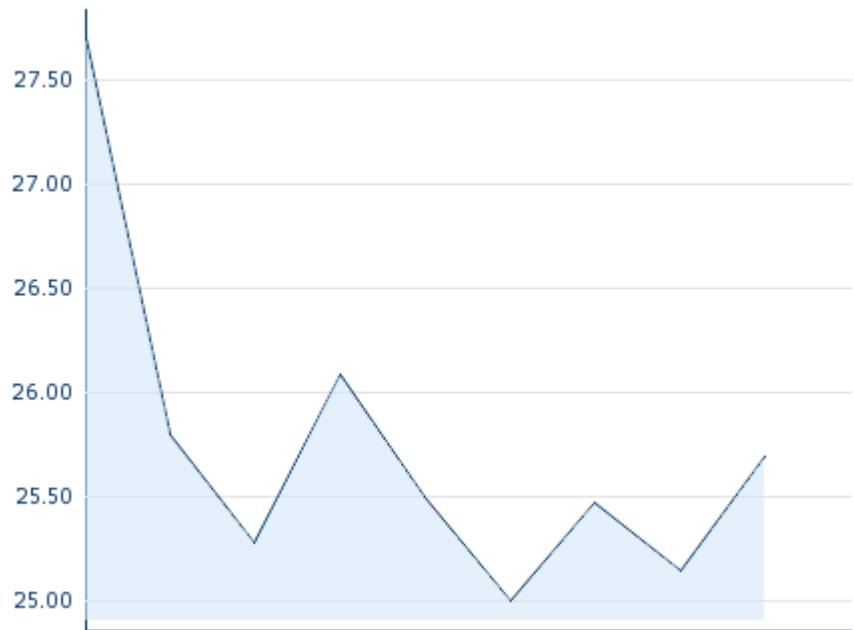

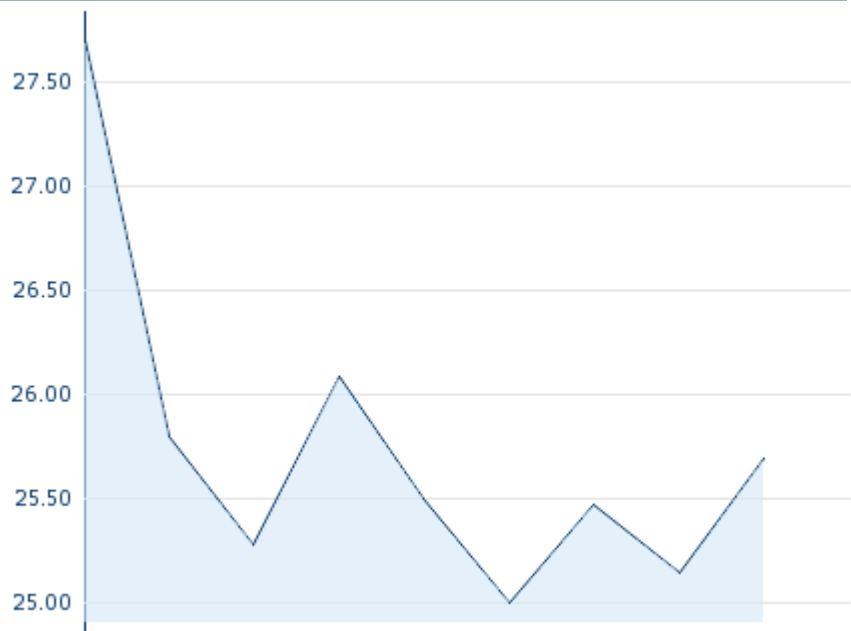

The Rental segment combines all of the businesses that are aimed at the value-enhancing management of the company's own residential units.
