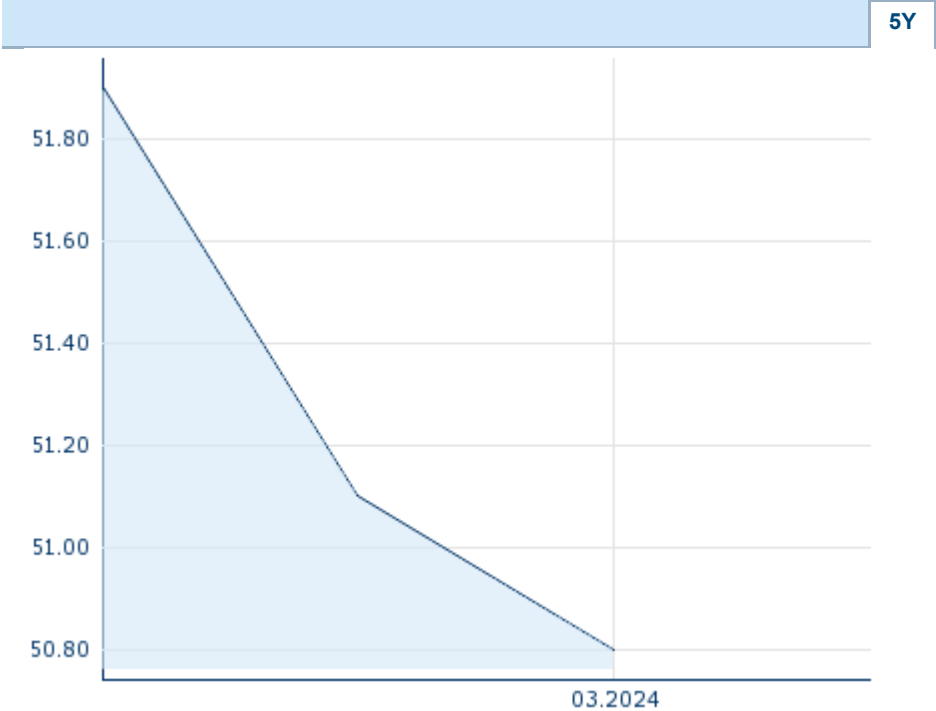

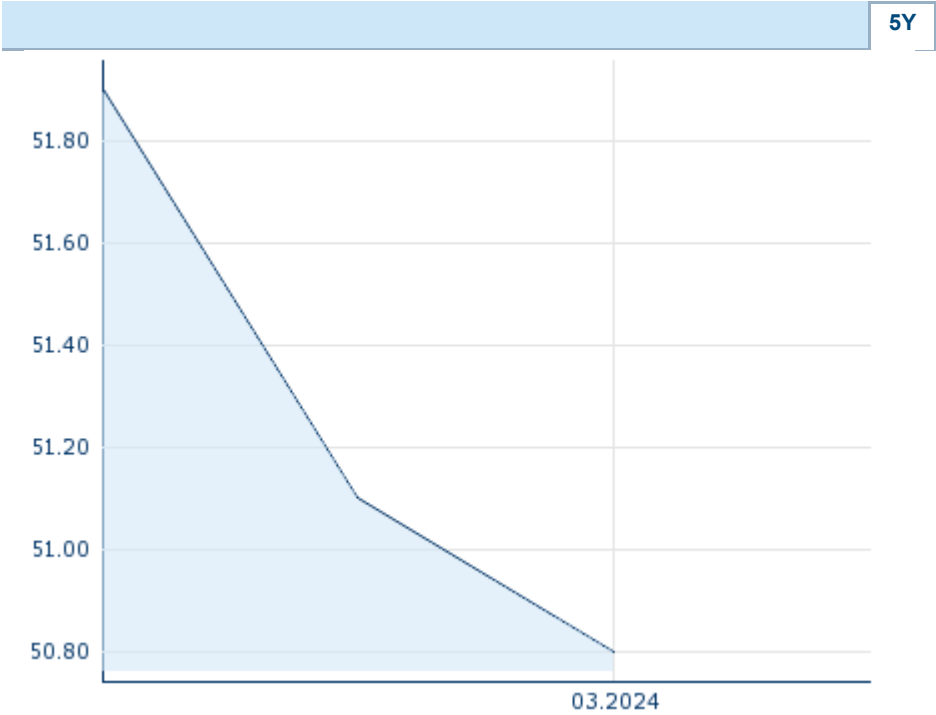

The Market and Wealth Services segment comprises industry leaders pershing and clearance and collateral management, and treasury services business.
