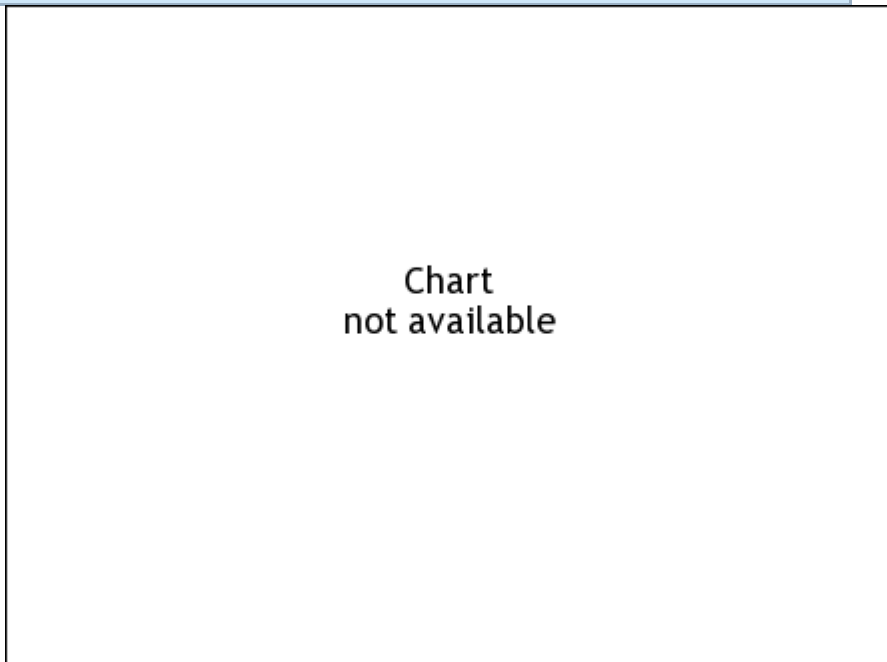

It operates through the following segments: U.S. Refreshment Beverages, U.S. Coffee, and International.
