

Performance goal and investment strategy

The fund's objective is to outperform Czech medium-term government bond yields in the long term. This is an open-ended mutual bond fund with a medium-term recommended period of investment. The key source of the fund's income is mainly interest yields from debt instruments. The fund mainly buys medium and long-term government bonds and partly also high quality corporate bonds at investment level. The fund is managed actively, and the fund manager can also make use of short-term market opportunities and thus flexibly manage the interest risk. The fund is suitable for investors who do not want to invest in stocks, but the yields of money funds or term deposits are insufficient for them.
