It operates through the following segments: Belgium, the United Kingdom, Continental Europe, Asia, Reinsurance, and General Account. The Belgium segment offers life and non-life products to private individuals and small to medium enterprises under the name of AG insurance. The United Kingdom segment provides non-life insurance solutions and related life protection businesses, with personal and commercial line markets. The Continental Europe segment consists of European insurance activities excluding Belgium and the United Kingdom. The Asia segment is organized in the form of joint ventures with local partners and financial institutions in Hong Kong, China, Malaysia, Thailand, and India. The General Account segment comprises activities not related to the core Insurance business, such as group finance and other holding activities. The company was founded in 1990 and is headquartered in Brussels, Belgium.
