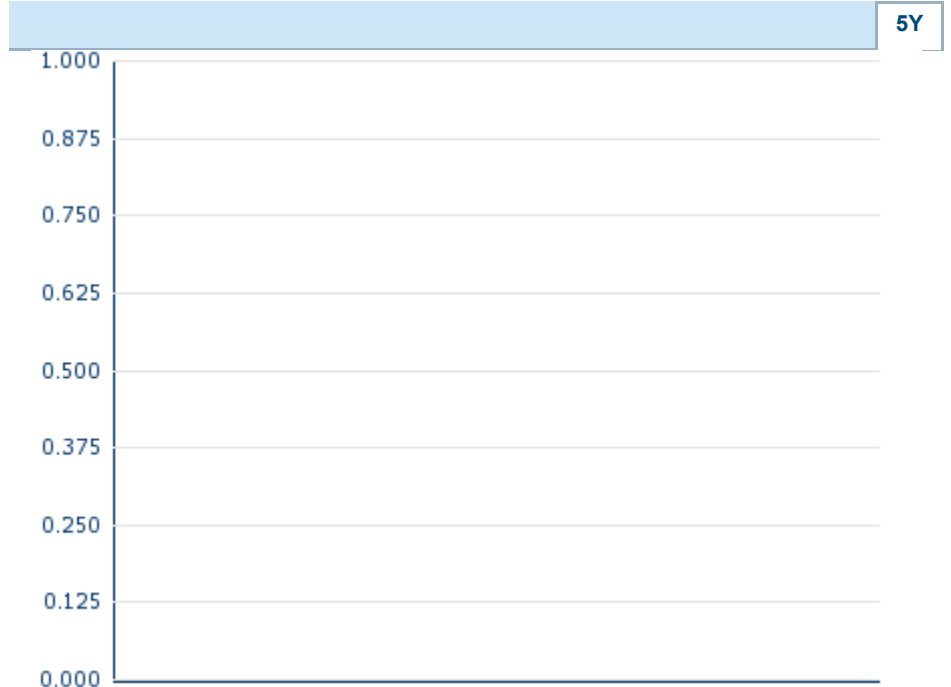

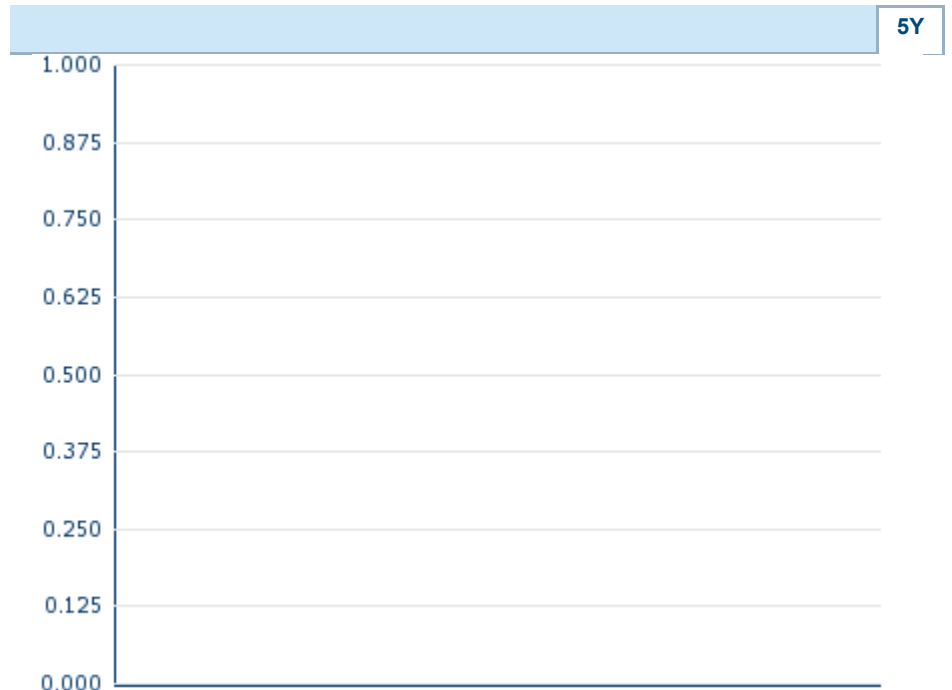

It operates through the following segments: Installation and Flushing Systems, Piping Systems, and Bathroom Systems.
