It operates through the following business segments: Pharmaceutical Products, Diagnostic Products, Nutritional Products and Medical Devices. The Established Pharmaceutical Products segment refers to branded generic pharmaceutical products. The Diagnostic Products segment includes diagnostic systems and tests for blood banks, hospitals, alternate-care testing sites. The Nutritional Products segment includes adult and pediatric nutritional products. The Medical Devices segment includes electrophysiology, heart failure, vascular and structural heart disease, cardiovascular diseases, and diabetes care products for neuromodulation devices for the management of chronic pain.
