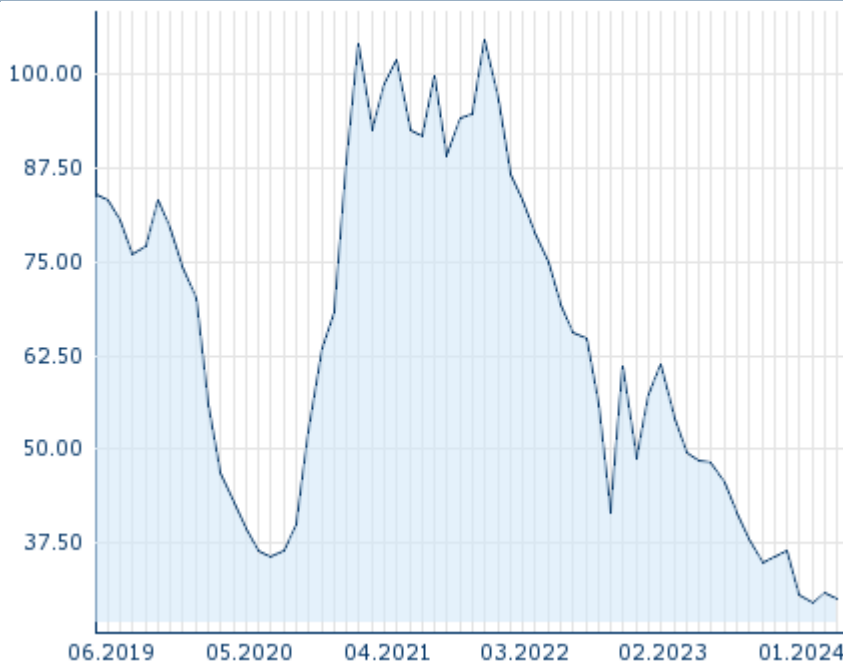

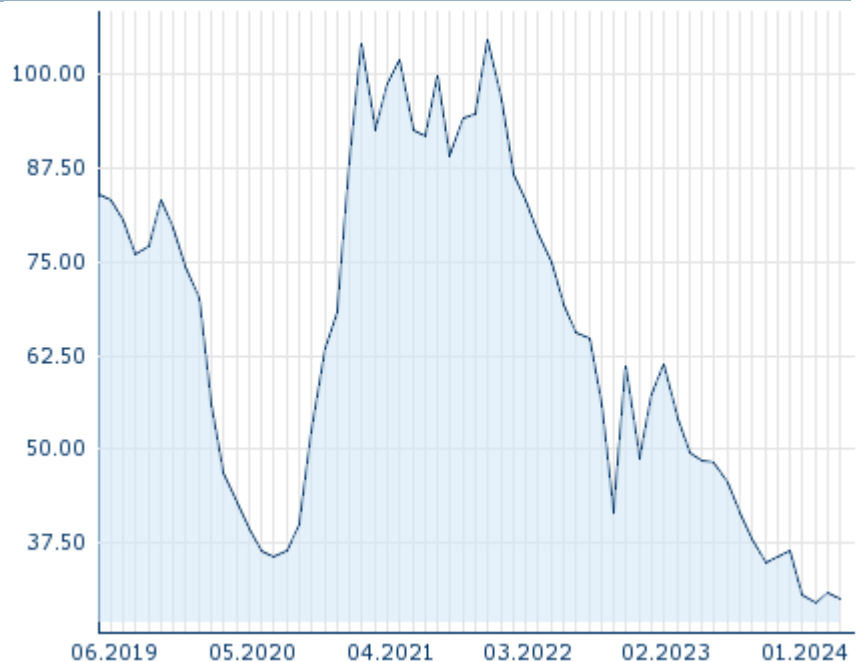

The Division Pulp is involved in the production and procurement of dissolving pulp for fiber production.
