The Continental Europe segment consists of European insurance activities excluding Belgium and the United Kingdom. The Asia segment is organized in the form of joint ventures with local partners and financial institutions in Hong Kong, China, Malaysia, Thailand, and India. The General Account segment comprises activities not related to the core Insurance business, such as group finance and other holding activities. The company was founded in 1990 and is headquartered in Brussels, Belgium.
