

The fund is managed actively and invests mainly in a globally distributed portfolio of securities of equity collective investment funds and also stocks. The fund emerged by being transformed from the Globaltrend FF fund. The fund's currency is not hedged so the investor bears the currency risk. In view of the investment strategy, the fund is suitable for regular investment and of being part of the equity component of the investment portfolio.
