

Performance goal and investment strategy

The fund's performance objective is to outperform the yields of deposit bank products. This is a bond mutual fund of very short-term investments. The fund is suitable for investors, who want to achieve a better return than in term deposits with the knowledge that they can suffer even a minor loss in the negative development of interest rates. The fund's portfolio particularly consists of bonds with a variable or fixed coupon, which in most cases are bought with the intention to hold them until maturity.
