Performance goal and investment strategy

The fund's performance objective is to outperform Czech government bond yields in the long term by investments in bonds of neighbouring countries. This is an open-ended mutual bond fund with a medium to long-term recommended investment period. The fund is suitable for investors looking for a higher yield than that offered by domestic bond funds. The aim is to achieve an excess yield thanks to the ongoing convergence of interest rates of Central European markets and the European Monetary Union. The fund is managed actively, which means that the fund manager can also make use of short-term market opportunities. The key source of the fund's income is mainly interest yields from debt instruments. The fund mainly buys government bonds of European Union candidate and member countries. The fund is only partly secured in monetary terms and investing in it is primarily associated with interest and currency risk.





