The neutral weight of the share of the equity component in the assets of the mutual fund is 10%, with the option of going up to 20%. The fund's performance target is to surpass the yields of the Czech Republic mid-term state bonds through a combination of investments into low-risk bonds and a small share of stock. The mutual fund carries a currency risk arising from investments made in local currencies. This risk in case of the equity component is actively managed by the available hedge instruments.
