The Operations segment offers increasing cost efficiency through the rationalization of production plant structure, improving quality, demand planning, and the optimization of industrial assets. The APAC segment is involved in mature markets with more moderate growth but lower market share than in the European markets and emerging markets with higher growth expectations due to new swimming pool construction and a greater focus on public swimming pools in the Asian markets.
