It operates through the following segments: Automotive excluding AVTOVAZ, AVTOVAZ, Sales Financing and Mobility Services. The Automotive excluding AVTOVAZ segment engages in production, sales, and distribution of passenger cars, and light commercial vehicles, and provides automotive services. The AVTOVAZ segment consist Russian automotive group AVTOVAZ and its parent company Alliance Rostec Auto B.V. The Sales Financing segment engages in operating activity carried out for the distribution network and final customers by RCI Banque, its subsidiaries and investments in associates and joint ventures. The Mobility Services segment provides services for new mobilities. Its brands include Renault, Dacia, LADA, Alpine, and Mobilize. The company was founded by Louis Renault in 1898 and is headquartered in Boulogne-Billancourt, France.
