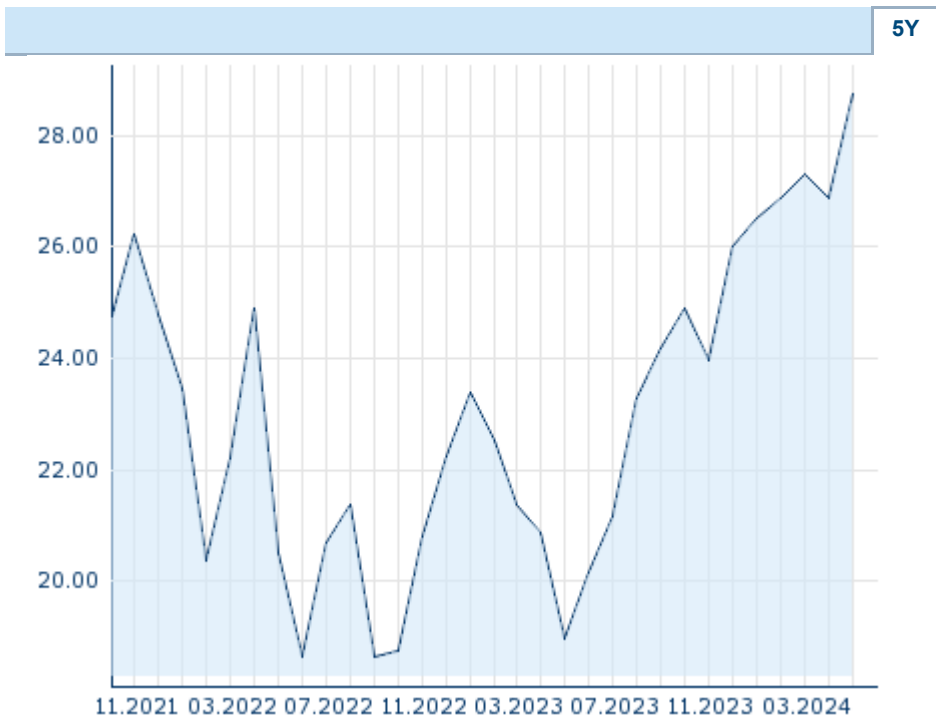

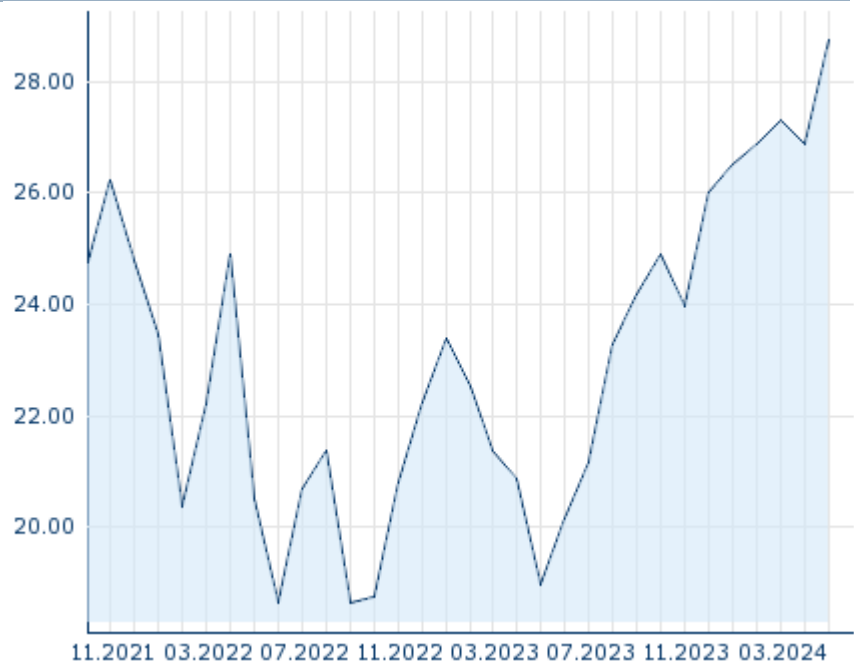

The company was founded in 1924 and is headquartered in Hilversum, The Netherlands.
