The Guaranteed Pension consists of products encompassing long-term savings for pensions, where the customers have a guaranteed return or benefit on the saved funds. The Other segment comprises Storebrand ASA, as well as the company portfolios and smaller subsidiaries. The company was founded on May 4, 1847 and is headquartered in Lysaker, Norway.
