It operates through the following business segments: Wildcatch; Farming; and Value-added Processing, Sales, and Distribution (VAPS&D). The Wildcatch segment refers to the management of Havfisk AS is a ship owning company, with trawlers involved in wild catches; and Lerøy Norway Seafoods AS, which involves in the receipt and processing of wild caught whitefish. The Farming segment includes the production, harvesting, and filleting of salmon and trout. The VAPS&D segment processes, sells, and markets salmon, trout, other species, and raw materials. The company was founded on April 7, 1995 and is headquartered in Bergen, Norway.
