The Corporate and Investment Banking segment derives income from the sale of products and services to the largest international and local corporations. The ALM and Centre segment includes central operations such as financing of other groups segments, including liquidity, interest rate risk, and FX risk management. The Santander Consumer segment focuses mainly on loan products such as car loans, credit cards, cash loans, installment loans, and lease products. The company was founded in 1857 and is headquartered in Warsaw, Poland.
