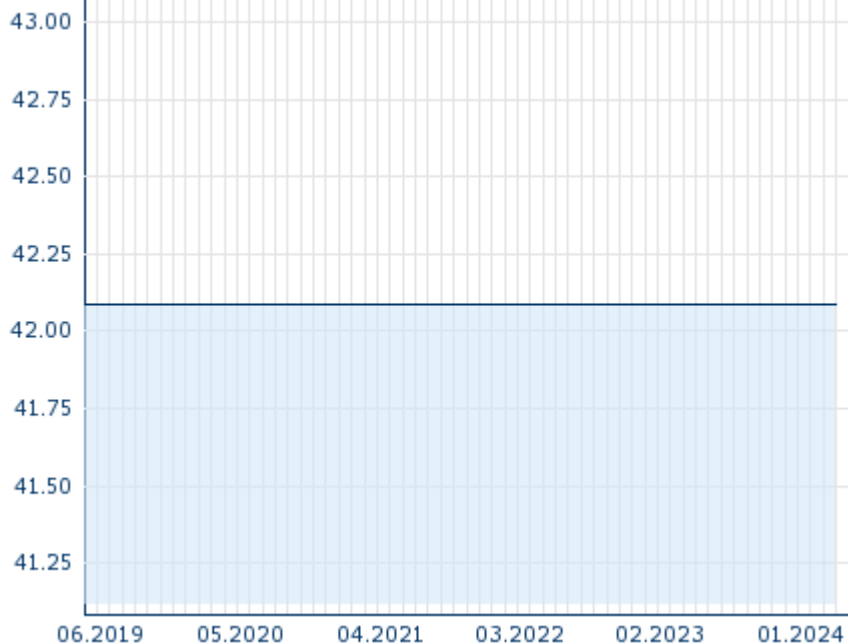

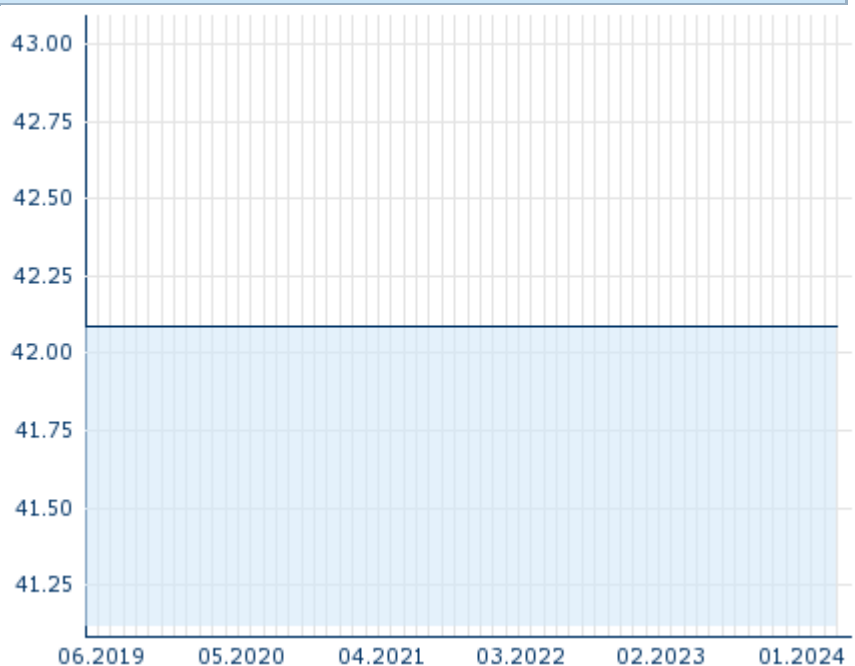

The Corporate Insurance segment offers motor and non-life insurance products to companies.
